

TOUCHMARK ALCOHOL POLICY

Effective: 1/1/2025

Important Note

This policy statement has not been approved or adopted by Touchmark's management. It is a layman's interpretation of the applicable Arizona laws. If you are in doubt about any claim or statement made herein, please check with Touchmark's management for their interpretation of the applicable Statutes and/or their related Rules and Regulations.

Locations and Restrictions

Alcohol may only be purchased in the following locations: Sterling Dining Room, Private Dining Room and Charley's Pub.

Alcohol may only be consumed in the following locations: Sterling Dining Room, Private Dining Room, Charley's Pub & Corner, Granite Mountain Room, Hoyle Room, Theater Room, Grand Lodge Lobby, Great Room and Patio. See attached Diagram of allowed consumption locations.

Please obey the "No alcohol beyond this point" signs.

Legal Considerations

Please don't argue with the servers or other Touchmark staff. They are obeying the law and you are expected to do the same. Failure to follow these regulations may result in the temporary invalidation of Touchmark's liquor license. That is not an achievement which you would want to have spread around the campus.

Purchase of Bottled Wine

If you have purchased a bottle of wine to drink at dinner but have not finished it.

Tell the server that you wish to take the remaining wine home. If the wine bottle uses a cork, the server is expected to insert it back into the bottle and cut it off flush with the top. If the wine bottle uses a screw-top, the server is expected to tighten it and seal it with tape.

If you want to buy a bottle of wine "to go" (you are not staying for a meal).

You must purchase a food item of some kind. Buying a meal is not necessary - an appetizer or side dish will meet the legal requirements. If the wine bottle uses a cork, the server is expected to remove it, insert it back into the bottle and cut it off flush with the top. If the wine bottle uses a screw-top, the server is expected to break the seal, re-tighten it and seal it with tape.

Applicable Statute regarding Wine To-Go

32. For a licensee or employee to knowingly allow spirituous liquor to be removed from the licensed premises, except in the original unbroken package. This paragraph does not apply to any of the following:

(a) A person who removes a bottle of wine that has been partially consumed in conjunction with a purchased meal from licensed premises if a cork is inserted flush with the top of the bottle or the bottle is otherwise securely closed.
